

The Unanimous Declaration of the Free Peoples of Earth, When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator, or by their mere existence, with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, --That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.--Such has been the patient sufferance of these Free Peoples of Earth under their controlled governments, guided by foreign entities and individuals towards intolerable oppression, digital enslavement, the loss of bodily autonomy, the removal of the right to pursue happiness; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present Governments around the world is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these Free Peoples of Earth. To prove this, let Facts be submitted to a candid world.

Governments have installed the will or agenda of foreign organizations or individuals without the informed consent of the the Sovereign Free Peoples. (Treason)

Governments have ignored petitions, co-opted opposition, and ruled by decree using emergency powers never proven to be necessary for the public good, and have extended "temporary measures" indefinitely, which undermine constitutionally protected rights and freedoms. (Human Rights Abuses)

Governments contain many public servants who are personally invested in products they are mandating the Sovereign Free Peoples submit to taking in order to be granted the privilege of exercising freedom they already possess. (Conflict of Interest, Coercion, Violation of Nuremburg Code, Human Rights Abuse)

Governments under advisement of foreign actors and institutions have co-opted constitutional judges and lawyers to validate or confirm government actions as "constitutionally compliant" when they are clearly not. (Corrupting the Judiciary, Treason)

Governments are eroding the rights to protest and to property, as The Free People of Earth voice objections to invasions on the rights of the people. Protest is a constitutionally protected right, and engaging in the act is not justification for government to seize or freeze assets. (Human Rights Abuses)

Governments have allowed multi-national corporations to inflate fair market value of housing and residential real estate through predatory and anti-competitive practices, destroying the right of the Sovereign Free Peoples to obtain shelter at reasonable cost and the right to own property, forcing The Free Peoples of Earth to become leaseholders of corporate assets in order to retain shelter from the elements. (Crony Corruption)

Governments have collaborated with international organizations and corporations to install and implement digital technology which undermines the Sovereign Free Peoples right to privacy, the right to engage in commerce, to dissent openly without penalty in form of free expression. (Human Rights Abuse, Crony Corruption)

Governments have enacted laws and regulations which criminalize free speech, using arbitrary and loosely worded interpretations to allow relevance and application to be at the discretion of judges and policy makers. (Human Rights Abuse)

Governments have created policies and mandates which destroy domestic small businesses through restriction and forced closure, while allowing foreign and international business to remain open without justification to explain this hypocrisy. (Human Rights Abuse, Crony Corruption)

Governments have directed their military to engage in psychological operations against their own people in clear breach of protections that exist to prevent governments using military force against their Free Sovereign Peoples. (Criminal Breach of Law)

Governments have restricted the ability of the Free Sovereign Peoples to travel outside of their national borders, and also within *their* sovereign territory, which Sovereign Free People are in possession of the right to exist anywhere within and travel freely unmolested without question. (Human Rights Abuse)

Governments have fostered and created an environment where doctors are unable to fulfill their oath to "Do No Harm" without penalty and cruel and unusual punishment in retaliation. (Undermining Public Health)

Governments have imposed taxes payable to foreign entities without the consent of The Free Peoples of Earth whom they represent. (Treason, Criminal Theft)

Governments have enacted laws which undermine the Right of the Sovereign Free Peoples to a fair and impartial trial. (Human Rights Abuse)

Governments have engaged in genocidal rhetoric, demonizing visible minority groups with dehumanizing labels and unjustifiable blame for societies problems. (Human Rights Abuse, Steps of Genocide)

Governments have engaged in economically destructive financial practices and executed the will of international financial institutions to weaken the spending power and economic prosperity of the Sovereign Free Peoples, while denying the Right of the People to issue their own currencies without debt or usury to foreign institutions. (Treason, Criminal Theft, Financial Fraud)

Governments have violated their oaths of office by failing to ensure all policies and laws are in alignment with the rights and freedoms of the Sovereign Free Peoples, and to ensure the will of the people is represented above all other interest. (Breach of Oath, Ruling without the Consent of the Governed)

Governments are engaging in manipulation of journalism, denying the Right of the people to a free and honest press, manufacturing consent, and employing fabricated polling to bypass informed debate. (Subversion of Democratic Principle and Process)

Governments are using hackable software and easily manipulated electoral practices to undermine the integrity of the Democratic Process. (Election Tampering)

Governments have collected and sold our data to our enemies and foreign corporations and organizations without our knowledge. (Breach of Trust, Human Rights Abuse)

In every stage of these Oppressions We have Petitioned for Redress in the most humble terms: Our repeated Petitions have been answered only by repeated injury. A Government that rules by decree and has engaged in every act which may define a Tyrant, is unfit to be the ruler of a free people.

Nor have We been wanting in attentions to our unaware fellow Sovereign Individuals not yet supporting us. We have warned them from time to time of attempts by their governments to engage in unwarrantable and treasonous actions which seek to enslave us to the will of foreign powers. We have reminded them of the truth of our natural rights. We have appealed to their humanity and cited the common plight, and we have conjured them by the ties of our common kindred to disavow these usurpations, which, would inevitably effect us all alike. They too have been deaf to the voice of justice and of Human Rights for All. We must, therefore, acquiesce in the necessity, which denounces our Separation, and hold them, as we hold the rest of mankind, Enemies in War, in Peace Friends.

We, therefore, the Representatives of the The Free Peoples of Earth, The Sovereign Free Peoples Naturally Occurring upon the lands within which we reside, in General assembly of our own self appointment, appealing to the Supreme Judge of the world, (God / The Laws of Nature) for the rectitude of our intentions, do, in the Name, and by Authority of the good People of The Earth, solemnly publish and declare, That these Lands occupied by The Free People of Earth are, and of Right ought to be Free and Independent Republics completely removed from the perceived and illegitimate authority of Treasonous Public Servants and the International Organization and Foreign Individuals they represent; that we are Absolved from all Allegiance to the Globalist Agenda and their International Network of Global Institutions Seeking to control and rule The Free Peoples of Earth, and that all political connection between us, and our lands and the aforementioned Entities and Individuals, is, and ought to be totally dissolved; and that as Free and Independent Republics, we have full Power to levy War, conclude Peace, contract Alliances, establish Commerce, and to do all other Acts and Things which Independent Republics may of right do. And for the support of this Declaration, with a firm reliance on the protection of divine Providence, we mutually pledge to each other our Lives, our Fortunes and our sacred Honor.
